**WHEREAS**, on 7 July 2020, the Bicol Medical Center published the Invitation to Bid for the Procurement of Medical & Other Health Related Equipment (1) (ITB No. 2020-19) in the Philippine Government Electronic Procurement System (PhilGEPS) and Bicol Medical Center (BMC) Websites as well as at conspicuous places reserved in the premises of BMC, continuously, for seven (7) days;






