WHEREAS, on 2 July 2020, the Bicol Medical Center published the Invitation to Bid for the Procurement of Hospital Beds (ITB No. 2020-18) in the Philippine Government Electronic Procurement System (PhilGEPS) and Bicol Medical Center (BMC) Websites as well as at conspicuous places reserved in the premises of BMC, continuously, for seven (7) days;

WHEREAS, in response to said advertisement, eight (8) bidders, namely: Phil. Med. Dental Specialties, Wise General Merchandise, Dynamed Healthcare, Inc., Saviour Meddevices, Inc., Variance Trading Corp., Medical Center Trading Corp., Bataan Manufacturing Co., Inc. and Elan Vita Diagnostic Solutions showed their interest to join the public bidding for the Procurement of Hospital Beds (ITB No. 2020-18);

WHEREAS, on 10 July 2020, the BMC BAC conducted the pre-bid conference attended by the bidders. The BAC and the bidders agreed on the submission of bids in accordance with R.A. No. 9184, otherwise known as the *Government Procurement Reform Act*. The BAC noted queries from the bidders and emphasized that any statement made during the conference will not change any provision in the bid documents, unless a supplemental bid bulletin is issued;

WHEREAS, on 14 July 2020, the BAC issued a Supplemental/Bid Bulletin (Addendum No. 2020-01) within the reglementary period prescribed by law; (Please refer to BAC Resolution No. 113, Series 2020)
