**BAC RESOLUTION DECLARING LOWEST CALCULATED RESPONSIVE BIDS AND
RECOMMENDING AWARD FOR THE PROCUREMENT OF LINEN SUPPLIES
(ITB NO. 2020-31)**

**RESOLUTION NO. 181
Series 2020**

WHEREAS, on 14 August 2020, the Bicol Medical Center published the Invitation to Bid for the Procurement of Linen Supplies (ITB No. 2020-31) in the Philippine Government Electronic Procurement System (PhilGEPS) and Bicol Medical Center (BMC) Websites as well as at conspicuous places reserved in the premises of BMC, continuously, for seven (7) days;

WHEREAS, in response to said advertisement, three (3) bidders, namely: England Textiles, Straightforward Fashion Mdse., and Zhujar Mfg., Inc, expressed their interest to join the public bidding for the Procurement of Linen Supplies (ITB No. 2020-31);

WHEREAS, on 24 August 2020, the BMC BAC conducted the pre-bid conference attended by the bidders. The BAC and the bidders agreed on the submission of bids in accordance with R.A. No. 9184, otherwise known as the *Government Procurement Reform Act*. The BAC noted queries from the bidders and emphasized that any statement made during the conference will not change any provision in the bid documents, unless a supplemental bid bulletin is issued;

WHEREAS, on 28 August 2020, the BAC issued a Supplemental/Bid Bulletin (Addendum No. 2020-01) within the reglementary period prescribed by law; (*Attached as Annex "A"*)

WHEREAS, on 7 September 2020, the BAC opened the bids attended by three (3) bidders. During the eligibility check, only two (2) bidders were declared eligible and complying for having submitted complete eligibility, technical and financial requirements:




